### WORKING RELATIONALLY IN PSYCHOANALYTIC SUPERVISION

This course explores working relationally in psychodynamic supervision, a clinical supervision model based on relational psychoanalytic thinking. This model puts the supervisory relationship at the center of the process. Research from the psychoanalytic supervision literature, the counseling-psychology supervision literature, and from the fields of psychotherapy, education, cognitive psychology, and neuroscience provide mounting evidence for the pedagogic effectiveness of affectively rich, experiential, relationship-focused modes of teaching like this approach. Supervisors working within this model offer the benefit of their knowledge and experience and help their supervisees develop the emotional/relational skills required of an effective psychotherapist. Supervisors do this while holding a view of their authority as a supervisor that generates a safe and ethical context for emotional/relational learning. A video of actual supervision conducted by the instructor will be viewed and analyzed, and vignettes from her recent book, related work, and other published material will be discussed.

In 2023 (until the end of September), at least 54 shootings took place in schools and universities, impacting surrounding communities. Deaths by school shootings account for a small percentage of gun deaths among youth to date, but the numbers have been increasing since 2017. Such events require more accurate risk assessment training to prevent future incidents. This workshop will identify and describe three psychological types of school shooters: traumatized, psychotic, and psychopathic. Each will be illustrated through a case history. The workshop will then present an overview of threat assessment, discussing the concepts of "leakage," "attack-related behavior," and "evidence of imminence," along with examples of warning signs from actual school shootings.

(Case material will include personal writings and drawings from perpetrators, which contain explicit content some might find disturbing.)

# HELPING CLIENTS RESOLVE INTERPERSONAL DIFFICULTIES USING COMBINED INDIVIDUAL AND GROUP THERAPY: A Modern Analytic and Intersectional Approach

This three-hour workshop will explore how combined individual and group therapy is an effective treatment approach for clients stuck in interpersonal patterns that limit their relationship satisfaction. Group + individual helps clients shift relational dynamics that are difficult to uncover and address through individual therapy alone. It also helps them understand their emotional reactions to others more deeply and work through their fears and anxieties related to intimacy in a safe environment. Clients can practice skills in the "laboratory" of interpersonal group therapy and bring emotional reactions and material back to individual therapy for deeper exploration.

Participants will learn key elements of modern analytic and intersectional approaches to group psychotherapy. We'll distinguish constructive and destructive aggression, the critical role modern analysis suggests aggression plays in resolving long-standing interpersonal issues, and how an intersectional approach helps members explore, know, and claim different parts of their identities.

This course introduces ideas and concepts at the center of the Group Analytic (GA) approach. Developed by S.H. Foulkes, GA is an established model for group therapy used in many countries around the world that focuses on relationships and interactions between group members. It explores patterns of communication, roles, power dynamics, and the influence of social and collective factors on the individual. Contrary to other group therapy approaches, GA formulates different therapeutic factors, such as resonance and mirroring, integrates the individual (personal matrix) with the group (group matrix), and examines unconscious social forces and their impact on the individual and the group (foundation matrix). Notably, GA developed the position of the Conductor (group therapist). Five distinguished group analysts from the UK, Israel, Brazil, and the U.S. will discuss the GA approach while elaborating on its main components, including the tripartite matrix, transference and countertransference, the language of the group, the Social Unconscious in GA, dreams, and the position of the group conductor.

#### MOSTLY DEAD IS SLIGHTLY ALIVE! Surviving Drug Addiction with your Psychoanalytic Psychotherapy Patients

This six-week course offers an experiential way of learning about clinical issues pertaining to drug addiction in the context of psychoanalytically oriented psychotherapy. The course, divided into six weekly topics, offers readings and materials associated to psychic aliveness, its risks and relation to isolation, omnipotence, embodiment and dissociation.

We will use music, poetry, film, and clinical case material to feel our way into each week's topic, providing a more embodied experience than the usual didactic approach to this material.

Through the presentation of dreaming as an expression of the spiritual psyche, a felt sense of the spiritual psyche in clinical practice and in everyday life will emerge. Participants' relationship to their own dream life will be catalyzed through reflective engagement and discussion. Dreaming – not ony at night but also in waking life – will be related to as a continuous mode of awareness and relationality that fosters vitality, imaginative interplay, and connection to our world and the cosmos.

**Clara Brandt, Psy.D.,** is a psychologist in private practice in Oakland, where she works with adult individuals and couples. She teaches and supervises at Access Institute and is the former chair of the Education Committee at NCSPP.

**Robi Friedman**, **Ph.D.**, is a clinical psychologist and group analyst based in Israel. Dr. Friedman is the former president of the International Group Analytic Society and co-founder of the Israeli Institute of Group Analysis.

**Earl Hopper, Ph.D.**, is a psychoanalyst, group analyst, and organizational consultant in private practice in London. He is a Fellow of the British Psychoanalytical Society, an Honorary Member of the Institute of Group Analysis and the Group Analytic Society International, and a Distinguished Fellow of the American Group Psychotherapy Association. Dr. Hopper is the author and editor of numerous books and articles.

**Laura Kasper, Ph.D., CGP,** is a licensed psychologist in San Francisco. She has led trainings at group therapy conferences (AGPA, NCGPS, COGPS, MAGPS) is Adjunct Clinical Faculty at Stanford Medical School, where she teaches residents group therapy and is a group facilitator for Stanford Business School's Interpersonal Dynamics course.

**Peter Langman, Ph.D.,** is a known expert in the psychology of school shooters. His trainings identify warning signs of potential perpetrators of violence before it occurs and how school leadership can effectively utilize threat assessment across their communities. This includes analyzing homework assignments, understanding motivations and justifications for violence, and exploring pathways to violence.

**Carla Penna, Ph.D.,** is a psychoanalyst and group analyst in Rio de Janeiro, Brazil, where she is the former president of the Brazilian Association of Group Psychotherapy and Society of Group Analytic Psychotherapy.

Joan Sarnat, Ph.D., ABPP, is a supervising analyst and member of the faculty at PINC. She has published two books and numerous papers elaborating a relational model of psychoanalytic supervision. Dr. Sarnat is in consultative and supervisory practice in Berkeley.

John Schlapobersky, BA Msc CGP, is a training analyst, supervisor, and teacher in the Institute of Group Analysis, London, and research fellow, Birbeck, University of London. He is in private practice at the Bloomsbury Psychotherapy Practice and works with individuals, couples, and groups. He has trained generations of group analysts, teaches internationally, and has published widely.

**Willow Pearson Trimbach, Psy.D., LMFT, MT-BC,** is Associate Professor and Director of Clinical Training, Clinical Psychology Department, CIIS. A licensed clinical psychologist, licensed marriage and family therapist, and nationally board certified music therapist, Dr. Pearson has a private practice in Oakland, where she sees adults and provides supervision. Dr. Pearson is co-editor and contributing author of *The Spiritual Psyche in Psychotherapy: Mysticism, Intersubjectivity, and Psychoanalysis*, published by Routledge (2021).

**Michael Wachter, M.D.,** is a psychiatrist in private practice in San Francisco. He is interested in the use of Narrative Medicine in psychotherapy to enhance embodiment in the clinical setting. Dr. Wachter has taught about addiction in psychoanalytic psychotherapy from this perspective and is board certified in Addiction Medicine.

Haim Weinberg, Ph.D., is a licensed psychologist in Israel and California, a group analyst, and certified group psychotherapist in private practice in Sacramento, California. He is the past president of the Israeli Association of Group Psychotherapy and of the Northern California Group Psycho-therapy Society. To date, Dr. Weinberg has published 10 books, 24 book chapters, and 55 articles.


