Humankind is reaching a breaking point whereby the prevailing forces of relating are wholly characterized by greed, hate, and domination. This worldview objectifies and reduces other humans perceived as different, and animals, birds, insects, trees, and plants as lesser and expendable. What if the universal attitude was one of kinship with all dynamic beings? A stance that values all forms of living matter as one of us; where relationships are characterized by reverence, reciprocity, and a sense of abundance. Possession of love, hate, and concern (Winnicott, Suttie, Fairbairn; selfhood and otherness (Laplanche, Goldin); and the thinking and kinship apparatuses (Bion) in equilibrium may engender abundant internal and external space for all of earth's creatures.

This course will offer contemplative space for being with and clinically organizing around the kinship object elements. Psychoanalytic and sociocultural synthesis may be incorporated into our clinical work as activism to help our clients (and us) experience greater wholeness and connection with the sentient world. Please come prepared for a deep, broad, and intimate discussion.

Education is never a neutral endeavor. The classroom is an environment where teachers and students bring hopes, fears, and unconscious fantasies about what it means to learn. Teaching requires a love of one's subject matter and a willingness to understand the disruptive nature of learning, for teacher and student. The multilayered dimension of teaching requires attentiveness to the teacher/student dyad and unconscious process as it unfolds in a classroom.

This course will include classroom experience where we read and explore what it means to provoke learning. Topics to be explored:

- Why teach?
- What constitutes a "mistake" in teaching?
- How do you engage a resistant learner?
- How do you encounter and work with negative and positive transferences in the classroom?
- Difference as an ethical encounter
- How can you engage unconscious process to enhance learning?
- How can teachers listen to what is not being said?

Transitioning into private practice involves many subtle shifts in orientation to clinical work. Many decisions must be made – decisions that hinge on personal needs, preferences, and interests not-yet familiar. The frame becomes newly personal. This is a time of considerable change, self-discovery, and development.

Simultaneously, this is often a solitary period in one's career. Many important questions are left to one's own best judgment without familiar spaces in which to receive support.

This three-week workshop is designed to support clinicians who are in the planning or beginning stages of starting their independent practices. With a focus on practical and clinical decision-making, particularly frame-related questions, we will work on developing the mindset of an independent practitioner. We will address questions about setting fees and policies, initial consultations and screening patients, and ongoing professional development.

In an era of managed care, how can psychoanalytic principles be woven into a community mental health system? By exploring hateful countertransference reactions – both his own and those of members of the community in which he practiced – Brian Ngo-Smith will examine professional tensions that arose in his work with an unhoused client. What do such reactions tell us about the complexities of working psychoanalytically in public practice settings? Through this lens we can begin to understand what a homeless client may represent to their city, as well as to their therapist. This lecture and discussion will consider how psychoanalytic thinking can challenge current "best practices" in community mental health by focusing on long-term stability, while also expanding these ideas into macro practice with larger systems that resist change.
